AND FURTHER AMEND by deleting the amendatory language of SECTION 14 of the printed bill in its entirety, and by substituting instead the following language:

(i) When the court enters an order in which the paternity of a child is determined or support is ordered, enforced or modified for a child, each individual who is a party to any action pursuant to this part shall be immediately required to file with the court and, if the case is a Title IV-D child support case, shall immediately file with the local Title IV-D child support office, for entry into the state registry of support cases, and shall update, as appropriate, the parties' and, for subdivisions (B)(I)(a)-(B)(I)(c), the child's or children's:

- (a) Full name and any change in name;
- (b) Social security number and date and place of birth;
- (c) Residential and mailing addresses;
- (d) Home telephone numbers;
- (e) Driver's license number;
- (f) The name, address, and telephone number of the person's employer;
- (g) The availability and cost of health insurance for the child; and
- (h) Gross annual income.

The requirements of this subdivision may be included in the court's order.

AND FURTHER AMEND by deleting the language "not less than the amount of the arrears" in the amendatory language of SECTION 15 of the printed bill and by substituting instead the language and punctuation "not less than two hundred fifty dollars (\$250.00) or, in the discretion of the court, up to the amount of the arrears,".
