**006778 – Commerce #2**

by adding the following new item at the end of Section 12:  
Item \_\_\_\_\_. In addition to any other funds appropriated by the provisions of this act, there is appropriated the sum of \$150,000 to the Department of Economic and Community Development for the sole purpose of funding minority business development centers in Knoxville, Nashville, and Memphis at \$50,000 for each location.

**006702 – Education #1**

by adding the following new item at the end of Section 12:  
Item \_\_\_\_\_. In addition to any other funds appropriated by the provisions of this act, there is appropriated the sum of three hundred sixty-five thousand dollars (\$365,000) to the Joe L. Evins Appalachian Center for Crafts for the sole purpose of operational and/or capital expenses.

**004542 – Education #2**

by adding the following new item at the end of Section 12:  
Item \_\_\_\_\_. In addition to any other funds appropriated by the provisions of this act, there is appropriated the sum of seventy-five thousand dollars (\$75,000) to the Tennessee Foreign Language Institute for operational expenses to be allocated as follows:  
Fifty thousand dollars (\$50,000) for the Memphis Center;  
Thirteen thousand dollars (\$13,000) for a part-time technician for video conferencing activities with elementary schools; and  
Twelve thousand dollars (\$12,000) for accounting services no longer provided by the state board of regents.

**0006705 – Finance, Ways, and Means #1**

by adding the following new item at the end of Section 12:  
Item \_\_\_\_\_. In addition to any other funds appropriated by the provisions of this act, there is appropriated the sum of \$600,000 to the Tennessee State Library and Archives for the sole purpose of implementing the Tennessee Electronic Library. It is the legislative intent that this be a non-recurring item.

**004542 – Finance, Ways, and Means #2**

by adding the following new item at the end of Section 12:  
Item \_\_\_\_\_. In addition to any other funds appropriated by the provisions of this act, there is appropriated the sum of \$1,372,498 to the Department of Audit in the Office of the Comptroller and \$1,388,000 to the Department of Revenue for the sole purpose of adjusting the compensation of auditors.

**006246 – Amendment #2**

by adding the following new item to SECTION 12 thereof:

Item \_\_\_\_\_. In addition to any other funds appropriated by the provisions of this act, there is appropriated the sum of one hundred fifty-five thousand three hundred dollars (\$155,300.00) representing estimated first year's funding costs for the purpose of implementing Senate Bill No. 171/House Bill No. 57. This appropriation shall take effect only if Senate Bill No. 171/House Bill No. 58 becomes a law.

**006243 – Amendment #3**

by adding the following new item to SECTION 12 thereof:

Item \_\_\_\_\_. In addition to any other funds appropriated by the provisions of this act, there is appropriated the sum of one-hundred fifty-seven thousand dollars (\$157,000.00) representing estimated first year's funding costs for the purpose of implementing Senate Bill No. 170/House Bill No. 58. This appropriation shall take effect only if Senate Bill No. 170/House Bill No. 58 becomes a law.

**006263 – Amendment #4**

by adding to SECTION 12 the following as a new, appropriately designated item:

Item \_\_\_\_\_. There is hereby appropriated a sum sufficient to provide a twenty dollar (\$20.00) employer match to the State's 401(k) Plan for State employees compensated on the centralized State payroll system, for employees of institutions under the University of Tennessee System and for employees of institutions under the Board of Regents System pursuant to the provisions of Tennessee Code Annotated, Title 8, Chapter 25.

**006557 – Amendment #17**

by adding the following new item at the end of Section 12:

Item \_\_\_\_\_. In addition to any other funds appropriated by the provisions of this act, there is appropriated the sum of \$171,600 to the appropriate entity of state government for the sole purpose of implementing SB 1722 / HB 1837, relative to increased penalties for the manufacture of certain drugs.

**006418 – Amendment #26**

by adding the following new item at the end of Section 12:

Item \_\_\_\_\_. In addition to any other funds appropriated by the provisions of this act, there is appropriated the sum of \$202,000 to the administrative office of the courts for the sole purpose of implementing the provisions of SB 38 - HB 710, relative to creating an additional chancery court in the 20th judicial district, if such bill becomes law.

In addition to any other funds appropriated by the provisions of this act, there is appropriated the sum of \$125,000 to the department of finance and administration for the sole purpose of making a grant in such amount to the Tennessee Valley Center for Minority Economic Development, to be used for providing technical assistance to disadvantaged businesses throughout the state.

**006664 – Amendment #43**

by adding the following new item at the end of Section 12:

Item \_\_\_\_\_. In addition to any other funds appropriated by the provisions of this act, there is appropriated the sum of \$161,802 to the Juvenile Code Commission for the sole purpose of funding operating expenses for fiscal year 1999-2000.

**0066912 – Amendment #46**

by adding the following new item at the end of Section 12:

Item \_\_\_\_\_. In addition to any other funds appropriated by the provisions of this act, there is appropriated the sum of \$345,000 to the department of finance and administration for the sole purpose of making grants to each community action agency as follows:

Item \_\_\_\_. In addition to any other funds appropriated by the provisions of this act, there is appropriated the sum of \$50,000 to the Upper Cumberland Human Resource Agency for the sole purpose of continuation of their homemakers program.

005905 – Amendment #57

by adding the following new item at the end of Section 12:
Item \_\_\_\_. In addition to any other funds appropriated by the provisions of this act, there is appropriated the sum of \$810,000 to the Department of Human Services for the sole purpose of allocating such sum in equal grants to each of the nine (9) human resource agencies.

**006762 – Amendment #61**

by adding the following new item at the end of Section 12:

Item \_\_\_\_\_. In addition to any other funds appropriated by the provisions of this act, there is appropriated to the civil legal litigation representation of indigents fund the revenue raised through the increase in the litigation tax to implement Senate Bill 747 / House Bill 1540, if such bill becomes law.

**00000 – Amendment # \_\_\_\_\_**

by adding the following new item at the end of Section 12:

Item \_\_\_\_\_. In addition to any other funds appropriated by this act, there is appropriated the additional sum of \$48,000,000 to the Bureau of TennCare for TennCare services.

Item \_\_\_\_\_. In addition to any other funds appropriated by this act, there is appropriated the additional sum of \$17,000,000 to the Department of Children’s Services for services to children.

Item \_\_\_\_\_. No funds appropriated by this act shall be used to fund a legislative office building.

Item \_\_\_\_\_. No funds appropriated by this act shall be used to fund a 2000 presidential preference primary in Tennessee.

**000000 – Amendment # \_\_\_\_\_**

by adding the following new item at the end of Section 11:

Item \_\_\_\_\_. The appropriation to the department of education is reduced by \$200,000 representing the cost of replacing computer equipment.
