

HOUSE BILL 2878

AN ACT to amend Tennessee Code Annotated, Title 3, Chapter 15; Title 9, Chapter 4; Title 9, Chapter 5; Title 37; Title 39, Chapter 13; Title 49, Chapter 1, Part 2 and Title 68, relative to the select committee on children and youth.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF TENNESSEE:

SECTION 1. Tennessee Code Annotated, Section 37-1-607(a)(1), is amended by deleting the language "and the select committee on children and youth".

SECTION 2. Tennessee Code Annotated, Section 37-1-607(a)(1), is amended in the last sentence of subdivision (E) by deleting the language "the children and family affairs committee of the house of representatives and the select committee on children and youth," and by substituting instead the language "and the children and family affairs committee of the house of representatives,".

SECTION 3. Tennessee Code Annotated, Section 37-2-205(f), is amended by deleting subdivision (4) in its entirety.

SECTION 4. Tennessee Code Annotated, Section 37-3-703(d), is amended by deleting the language "the chair of the health and human resources committee of the house of representatives, and the chair of the select committee on children and youth" and by substituting instead the language "and the chair of the health and human resources committee of the house of representatives".

SECTION 5. Tennessee Code Annotated, Section 37-3-604(a), is amended by deleting the language "the chair of the health and human resources committee of the house of representatives, and the chair of the select committee on children and youth" and by

substituting instead the language "and the chair of the health and human resources committee of the house of representatives".

SECTION 6. Tennessee Code Annotated, Section 37-1-182(a)(1), is amended by deleting subdivision (G) in its entirety.

SECTION 14. Tennessee Code Annotated, Section 37-5-603(b), is amended by deleting the language "the select committee on children and youth,".

SECTION 15. Tennessee Code Annotated, Section 37-5-604(a), is amended by deleting in its entirety the second sentence and by substituting instead the following:

The screening instrument shall be developed by the department.

the language "and to the health and human resources committee of the house of representatives".

SECTION 23. Tennessee Code Annotated, Section 68-1-125(d), is amended by deleting the language "the children and family affairs committee of the house of representatives and the select committee on children and youth" and by substituting instead the language "and the children and family affairs committee of the house of representatives".

SECTION 24. Tennessee Code Annotated, Section 68-140-521(e), is amended by deleting the language "to the health and human resources committee of the house of representatives, and to the select committee on children and youth" and by substituting instead the language "and to the health and human resources committee of the house of representatives".

SECTION 26. Tennessee Code Annotated, Section 3-15-510(f), is amended by deleting the language ", the select committee on children and youth".

SECTION 27. Tennessee Code Annotated, Title 3, Chapter 15, is amended by deleting Part 2 in its entirety.

SECTION 28. This act shall take effect July 1, 2010, the public welfare requiring it.
