AN ACT to amend Tennessee Code Annotated, Title 13, relative to training requirements for professional planners, building commissioners, and other administrative officials whose duties include advising planning commissions or boards of zoning appeals.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF TENNESSEE:

SECTION 1. Tennessee Code Annotated, Section 13-3-101(j)(2), is amended by deleting from the second sentence of said subdivision the following language:

and who has obtained a current certificate in the AICP Continuing Professional Development Program

SECTION 2. Tennessee Code Annotated, Section 13-3-101(j)(3), is amended by deleting from the third sentence of said subdivision the language "submit a copy of such member's certificate from the AICP Continuing Professional Development Program", and by substituting instead the language "be exempt from this requirement".

SECTION 3. Tennessee Code Annotated, Section 13-3-101(j)(7), is amended by deleting from the second sentence of said subdivision the language "file a copy of such member's current certificate from the AICP Continuing Professional Development Program" and by substituting instead the language "be exempt from this requirement".

SECTION 4. Tennessee Code Annotated, Section 13-3-201(b)(2), is amended by deleting from the second sentence of said subdivision the following language:

and who has obtained a current certificate in the AICP Continuing Professional Development Program

SECTION 5. Tennessee Code Annotated, Section 13-3-201(b)(3), is amended by deleting from the third sentence of said subdivision the language "submit a copy of such member's current certificate from the AICP Continuing Professional Development Program", and by substituting instead the language "be exempt from this requirement".

SECTION 6. Tennessee Code Annotated, Section 13-3-201(b)(7), is amended by deleting from the second sentence of such subdivision the language "file a copy of such member's current certificate from the AICP Continuing Professional Development Program", and by substituting instead the language "be exempt from this requirement".

SECTION 7. Tennessee Code Annotated, Section 13-4-101(c)(2), is amended by deleting from the second sentence of said subdivision the following language:

and who has obtained a current certificate in the AICP Continuing Professional Development Program

SECTION 8. Tennessee Code Annotated, Section 13-4-101(c)(3), is amended by deleting from the third sentence of said subdivision the language "submit a copy of such member's current certificate from the AICP Continuing Professional Development Program", and by substituting instead the language "be exempt from this requirement".

SECTION 9. Tennessee Code Annotated, Section 13-4-101(c)(7), is amended by deleting from the second sentence of such subdivision the language "file a copy of such member's current certificate from the AICP Continuing Professional Development Program", and by substituting instead the language "be exempt from this requirement".

SECTION 10. Tennessee Code Annotated, Section 13-7-106(b)(2), is amended by deleting this subdivision in its entirety and by substituting instead the following:

(2) Each full time or contract building commissioner or professional planner or other administrative official whose duties include advising the board of zoning appeals shall, each calendar year, attend a minimum of eight (8) hours of training and continuing education in one (1) or more of the subjects listed in subdivision (5) of this subsection. A professional planner who is a member of the American Institute of Certified Planners shall be exempt from this requirement.

SECTION 11. Tennessee Code Annotated, Section 13-7-205(c)(2), is amended by deleting this subdivision in its entirety and by substituting instead the following:

(2) Each full time or contract building commissioner or professional planner or other administrative official whose duties include advising the board of zoning appeals shall, each calendar year, attend a minimum of eight (8) hours of training and continuing education in one (1) or more of the subjects listed in subdivision (5) of this subsection. A professional planner who is a member of the American Institute of Certified Planners shall be exempt from this requirement.

SECTION 12. This act shall take effect upon becoming a law, the public welfare requiring it.
