

SENATE BILL 408

AN ACT relative to the boundary line between the counties of Davidson and Wilson.

WHEREAS, the parcels of real property listed within Section 1 of this act are currently located in Davidson County along the Wilson County line; and

WHEREAS, such parcels lack adequate ingress and egress for Davidson County emergency responders and school buses; and

WHEREAS, Wilson County is geographically situated to more effectively and efficiently provide these services; and

WHEREAS, Tennessee Code Annotated, Section 5-2-104, requires all applications for county boundary alterations to be accompanied by resolutions, approved by two-thirds vote of the county legislative body of each of the affected counties; now, therefore,

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF TENNESSEE:

SECTION 1. The boundary line between Davidson and Wilson Counties shall be altered in such manner as to detach the following described properties (totaling 0.225999 square miles) from Davidson County and to attach such properties to Wilson County:
