

HOUSE BILL 1230

AN ACT to amend Tennessee Code Annotated and Chapter 865 of the Public Acts of 2014, relative to legislative committees.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF TENNESSEE:

SECTION 1. Tennessee Code Annotated, Section 1-1-108(a), is amended by deleting "civil justice" and substituting "judiciary".

SECTION 2. Tennessee Code Annotated, Title 1, Chapter 3, is amended by adding the following as a new section:

References in this code to committees of the general assembly that no longer exist due to rule change of either the senate or house of representatives are deemed to be references to the committee that has jurisdiction of the subject matter pursuant to the rules of the appropriate chamber.

SECTION 145. Tennessee Code Annotated, Section 71-6-125(d), is amended by deleting "criminal justice" and substituting "judiciary".

SECTION 146. Section 8 of Chapter 865 of the Public Acts 2014, is amended by deleting "civil justice" and substituting "judiciary".

SECTION 147. The Tennessee Code Commission is requested to make appropriate changes to references to the names of the committees of the house of representatives pursuant to this act as supplements are issued and volumes are replaced.

SECTION 148. This act shall take effect upon becoming a law, the public welfare requiring it.
