

SENATE BILL 2162

By Johnson

AN ACT to amend Tennessee Code Annotated, Section 2-10-211; Title 3, Chapter 6; Title 4, Chapter 3, Part 10; Section 71-5-192 and Section 71-5-2517, relative to the department of finance and administration.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF TENNESSEE:

SECTION 1. Tennessee Code Annotated, Section 2-10-211, is amended by deleting the language "office of information resources" wherever it appears and substituting instead "division of strategic technology solutions".

SECTION 2. Tennessee Code Annotated, Section 3-6-115, is amended by deleting the language "office of information resources" wherever it appears and substituting instead "division of strategic technology solutions".

SECTION 3. Tennessee Code Annotated, Section 3-6-308(a)(1), is amended by deleting the language "office of information resources" and substituting instead "division of strategic technology solutions".

SECTION 4. Tennessee Code Annotated, Section 4-3-1003, is amended by deleting the language "sections" wherever it appears and substituting instead "divisions".

SECTION 5. Tennessee Code Annotated, Section 4-3-1003(a), is amended by deleting subdivisions (1)-(5) and substituting instead the following:

- (1) The division of accounts;
- (2) The division of administration;
- (3) The division of benefits administration;
- (4) The division of budget;
- (5) The office of the inspector general; and

(6) The division of strategic technology solutions.

SECTION 6. Tennessee Code Annotated, Section 4-3-1004, is amended by deleting the section.

SECTION 7. Tennessee Code Annotated, Section 4-3-1006(9), is amended by deleting the subdivision.

SECTION 8. Tennessee Code Annotated, Section 4-3-1007(2), is amended by deleting the language "due and payable" and substituting instead "due and payable, as the commissioner deems necessary with the objective of improving accountability and managing risk as provided for in title 9, chapter 18".

SECTION 9. Tennessee Code Annotated, Section 4-3-1007(3), is amended by deleting the language "demands or charges" at the end of the subdivision and substituting instead "demands or charges, as the commissioner deems necessary with the objective of improving accountability and managing risk as provided for in title 9, chapter 18".

SECTION 10. Tennessee Code Annotated, Section 4-3-1007(4), is amended by deleting the language "Inquire" and substituting instead "Inquire as needed".

SECTION 11. Tennessee Code Annotated, Section 4-3-1007(5), is amended by deleting the subdivision and substituting instead the following:

(5) Make available monthly reports on all receipts, expenditures, appropriations, allotments, and encumbrances of the state government to the governor, the department of audit, and the head of the department, office, or agency directly concerned;

SECTION 12. Tennessee Code Annotated, Section 4-3-1007(6), is amended by deleting the subdivision and substituting instead the following:

(6) Establish statewide accounting policies and practices that support the state's compliance with generally accepted accounting principles, state and federal laws, rules, and regulations. All such statewide policies shall become effective upon approval by the commissioner of finance and administration and the comptroller of the treasury;

SECTION 13. Tennessee Code Annotated, Section 4-3-1007, is amended by deleting subdivisions (12) and (13).

SECTION 14. Tennessee Code Annotated, Section 4-3-1007, is amended by adding the following as a new subdivision:

() Approve the use of electronic and other technological means to transfer funds whenever economically feasible, to eliminate paper documentation wherever feasible, and to increase fiscal efficiency and effectiveness;

SECTION 15. Tennessee Code Annotated, Section 4-3-1008(3), is amended by deleting the language ", through travel advances or reimbursement, or both,".

SECTION 16. Tennessee Code Annotated, Section 4-3-1008(3), is amended by deleting the semicolon at the end of the subdivision and substituting instead a period.

SECTION 17. Tennessee Code Annotated, Section 4-3-1008, is amended by deleting subdivisions (1), (2), (4), (5), and (6).

SECTION 18. Tennessee Code Annotated, Section 4-3-1010(a), is amended by deleting the language "and by § 67-5-2505".

SECTION 19. Tennessee Code Annotated, Section 4-3-1015, is amended by deleting the section.

SECTION 20. Tennessee Code Annotated, Section 71-5-192, is amended by deleting the language "office of information resources" and substituting instead "division of strategic technology solutions".

SECTION 21. Tennessee Code Annotated, Section 71-5-2517(e), is amended by deleting the language "office of information resources" and substituting instead "division of strategic technology solutions".

SECTION 22. This act shall take effect upon becoming a law, the public welfare requiring it.
