Education - As introduced, enacts the "Tennessee Local Education Capital Investment Act." - Amends TCA Title 67, Chapter 6.

[HB 0639](#) by *Coley (SB 1220 by *Niceley)

Criminal Procedure - As introduced, allows a county legislative body to send the annual report of the evaluation of the use of judicial commissioners to the legislative committees in electronic format. - Amends TCA Title 40.

[HB 1116](#) by *Coley, Hardaway (SB 0603 by *Jackson)

Criminal Offenses - As introduced, increases the punishment for reckless endangerment with a deadly weapon to a Class D felony if the offense occurred during a road rage incident. - Amends TCA Title 39, Chapter 13 and Title 55, Chapter 10, Part 2.

[HB 1312](#) by *Crawford (SB 1122 by *Lundberg)

Taxes, Sales - As introduced, allows municipality with a border region retail tourism development district that elects to remove property from the district to include adjacent property with an equal or lesser amount of acreage by resolution of the municipality. - Amends TCA Title 7, Chapter 40.

[HB 0809](#) by *Kumar, Hill T (SB 0886 by *Niceley)

Taxes, Real Property - As introduced, expands definition of agricultural land for purposes of greenbelt property tax program to include two noncontiguous tracts of land within same county totaling at least 15 acres and split only by public or private road. - Amends TCA Title 67, Chapter 5, Part 10.

Fire Prevention and Investigation - As introduced, extends the same police powers that municipal fire investigators have to certain salaried county fire investigators. - Amends TCA Section 39-17-1315 and Title 68, Chapter 102.

[HB 1058](#) by *Clemmons (SB 0936 by *Yarbro)

Education, Dept. of - As introduced, enacts the "Teacher Residency Program Grant Act"; requires the department to establish and administer a program of grants for university teacher preparation programs and LEAs to create teacher residency programs. - Amends TCA Title 49.

[HB 0215](#) by *Clemmons, Freeman, Hodges (SB 0259 by *Kyle)

Local Education Agencies - As introduced, requires local education agencies to develop and implement a "Stop the Bleed" program that requires each school in the LEA to place a bleeding control kit within the school; requires the department of education to develop a bleeding control kit training program for LEA employees. - Amends TCA Title 49, Chapter 1; Title 49, Chapter 2 and Title 49, Chapter 6.

Historical Sites and Preservation - As introduced, enacts the "Main Street Historic Tourism and Revitalization Act." - Amends TCA Title 4, Chapter 11, Part 1; Title 56, Chapter 4 and Title 67.

Taxes, Exemption and Credits - As introduced, exempts sales of gun safes from sales and use tax. - Amends TCA Title 67.

[HB 0605](#) by *Tillis, Carter, Whitson, Staples (SB 1458 by *Bailey, Bowling)

Taxes - As introduced, requires the commissioner of revenue to make a thorough study and investigation of the tax laws of other states. - Amends TCA Title 4; Title 65 and Title 67.

HB 1441 by *Todd (SB 1309 by *Lundberg)

Taxes, Sales - As introduced, authorizes the commissioner of revenue to give notice of the amount of any sales and use tax delinquency by certified mail to all persons having in their possession or under their control any credits or other personal property belonging to the dealer who is delinquent. - Amends TCA Title 67; Title 68 and Title 69.

HB 0524 by *Hill M, Hill T (SB 1434 by *Crowe)

Business and Commerce - As introduced, deletes provision that required the office of small business advocate to report the status of the office's web page project no later than February 15, 2013. - Amends TCA Title 4; Title 5; Title 6; Title 7; Title 12; Title 47; Title 48; Title 61 and Title 67.

TennCare - As introduced, reduces the time period from 30 days to 15 days for an enrollee or applicant for medical assistance to mail documentation of a material change affecting the enrollee or applicant's TennCare application. - Amends TCA Title 4; Title 33; Title 56; Title 68 and Title 71.

HB 0407 by *Doggett, Griffey, Littleton (SB 0425 by *Hensley)

Sexual Offenders - As introduced, extends the residential, work, and treatment restrictions on sexual offenders whose victims are minors from 1,000 feet to 2,000 feet from certain places where children are frequently present; prohibits a sexual offender from conducting overnight visit at a residence in which a minor resides or is present. - Amends TCA Title 40, Chapter 39.

HB 1463 by *Doggett, Whitson, Griffey (SB 1506 by *Hensley)

DUI Offenses - As introduced, increases offense from vehicular homicide to aggravated vehicular homicide when a person is convicted of driving with any amount of a Schedule I or Schedule II controlled substance in the person's blood, and the person has previously been convicted of driving under the influence or vehicular assault. - Amends TCA Section 39-13-218.

[HB 1340](#) by *Doggett, Byrd, Griffey, Hall, Ramsey, Lamberth, Faison, Howell, Littleton, Towns, Van Huss, Parkinson, Sanderson, Daniel, Potts, Curcio, Ogles, Farmer (SB 1163 by *Hensley, White)

Criminal Offenses - As introduced, creates a Class A misdemeanor of violating a no contact order issued to a domestic violence victim as part of a disposition in any criminal court. - Amends TCA Section 39-13-113.

[HB 1250](#) by *Byrd, Doggett (SB 0748 by *Hensley)

Criminal Offenses - As introduced, raises the penalty for criminal impersonation of a law enforcement officer from a Class A misdemeanor to a Class D felony; imposes a minimum fine of \$2,500 if the offense occurred while operating a motor vehicle. - Amends TCA Title 39, Chapter 16, Part 3.

[HB 1401](#) by *Hicks, Calfee, Marsh (SB 1475 by *Bailey)

District Attorneys - As introduced, alters the salary schedule for employees hired prior to July 1, 1994, with 25 or more years of credited service as an assistant district attorney general; prohibits any diminished or increased salary based on the reclassification; requires assistant district attorneys general be compensated by the same salary scale, as adjusted by cost of living or annual percentage increases. - Amends TCA Title 8, Chapter 7.

[HB 0185](#) by *Sexton C (SB 1355 by *Yager, McNally)

Election Laws - As introduced, revises method of nomination for a candidate in a special election for a state senate seat held in conjunction with the November regular election when the vacancy occurs within 45 days of the election. - Amends TCA Title 2.

[HB 1187](#) by *Chism, Dixie, Littleton, Powell, Van Huss, Halford, Moon, Sparks, Staples (SB 0844 by *Gilmore)

Veterans - As enacted, eliminates the fee for interment of an eligible veteran's spouse in a state veterans' cemetery. - Amends TCA Title 46, Chapter 6.

[HB 1327](#) by *Chism, White, Parkinson, Miller, Cooper, Camper, Vaughan (SB 0498 by *Akbari, Robinson)

Alcoholic Beverages - As introduced, authorizes leases entered into between Memphis and business owners holding a restaurant license from the alcoholic beverage commission to include provisions where the rent is calculated on gross sales, including gross sales of alcohol, of the business; prohibits a county from denying the issuance or renewal of a beer permit on the basis of a similar lease. - Amends TCA Title 57, Chapter 1; Title 57, Chapter 4 and Title 57, Chapter 5.

HB 0408 by *Doggett, Griffey, Cepicky (SB 0424 by *Hensley, Crowe)

Game and Fish Laws - As introduced, authorizes parents of landowners and tenants of farmlands to hunt and fish on such lands without a license to same extent as spouses and children of such persons under present law. - Amends TCA Title 70.

HB 0367 by *Hall, Doggett, Carter, Freeman (SB 1385 by *Bell)

Game and Fish Laws - As introduced, requires wildlife resources agency to issue permanent sport combination hunting and fishing licenses upon payment of a one-time \$10 fee to honorably discharged veterans of the United States armed forces. - Amends TCA Title 70.

HB 1468 by *Hurt, Miller (SB 0888 by *Niceley)

Agriculture - As introduced, authorizes the department of agriculture to provide notice of registered landrace varieties of hemp to licensed growers and processors via the department's website. - Amends TCA Title 4; Title 39, Chapter 17, Part 4; Title 43; Title 44, Chapter 6; Title 47, Chapter 26; Title 53; Title 67 and Title 68.

HB 0967 by *Cochran (SB 0432 by *Bell, Bailey)

Funeral Directors and Embalmers - As introduced, authorizes operators of crematory facilities who provide free services for the cremation of human remains to receive a refund of the permit fee paid for such services. - Amends TCA Title 62, Chapter 5; Title 63 and Title 68, Chapter 2.

HB 0776 by *Ramsey (SB 1135 by *Swann, Watson)

Local Education Agencies - As introduced, requires, rather than encourages, all public middle and elementary schools to place one or more automated external defibrillator (AED) devices within the school. - Amends TCA Title 49 and Title 68, Chapter 140, Part 4.

HB 0722 by *Coley (SB 0992 by *Kelsey)

Taxes, Privilege - As introduced, exempts judges and chancellors from the professional privilege tax assessed to persons licensed as attorneys. - Amends TCA Title 67, Chapter 4, Part 17.

HB 0246 by *Clemmons (SB 0253 by *Kyle, Crowe)

Taxes, Privilege - As introduced, phases out the professional privilege tax over a four-year period for tax years that begin on and after June 1, 2019. - Amends TCA Title 67, Chapter 4, Part 17.

HB 1059 by *Clemmons (SB 0964 by *Gilmore)

Taxes, Sales - As introduced, eliminates the sales tax on diapers. - Amends TCA Title 67, Chapter 6, Part 3.

Taxes, Privilege - As introduced, eliminates the special privilege tax on ammunition. - Amends TCA Section 8-8-201 and Title 70, Chapter 3.

[HB 1086](#) by ***Bricken (SB 0864 by *Bowling)**
Taxes, Sales - As introduced, exempts from sales and use tax car detailing services. - Amends TCA Title 67, Chapter 6.

[HB 0695](#) by ***Russell (SB 1455 by *Bailey)**
Taxes, Exemption and Credits - As introduced, creates sales and use tax exemption for sale of public safety and public works-related goods to certain nonprofit property owners associations. - Amends TCA Title 67, Chapter 6, Part 3.

[HB 0417](#) by ***Zachary (SB 0421 by *Hensley, Crowe)**
Taxes, Sales - As introduced, exempts, over a period of three fiscal years, the sales price of tickets for admission to an intercollegiate athletic event hosted by a college or university from the amusement sales tax. - Amends TCA Title 67.

[HB 0818](#) by ***Rudder (SB 1213 by *Crowe)**
Taxes, Business - As introduced, extends the business tax exemption under present law for providing mental or behavioral health services to providers of foster care, therapeutic and rehabilitative care, residential treatment, and other social assistance programs. - Amends TCA Title 67, Chapter 4, Part 7.

[HB 0095](#) by ***Shaw (SB 0060 by *Gilmore)**
Taxes, Exemption and Credits - As introduced, eliminates the sales tax on feminine hygiene products. - Amends TCA Title 67, Chapter 6.

[HB 0992](#) by ***Gant, Holt, Hulsey, Eldridge, Leatherwood, Sexton C, Lamberth, Travis, Lafferty, Zachary, Carter (SB 0457 by *Stevens, Niceley, Southerland)**
Taxes, Sales - As introduced, exempts certain sales of gold, silver, platinum, and palladium coins and bullion from the sales and use tax. - Amends TCA Title 67, Chapter 6.

[HB 1410](#) by ***Sherrell, Sexton C (SB 1462 by *Bailey)**
Taxes - As introduced, clarifies the "Taxpayer Bill of Rights" to require that any tax applications and notices be written in plain language. - Amends TCA Title 4; Title 6; Title 7; Title 9; Title 13; Title 45 and Title 67.

HB 1266 by *Holt (SB 1112 by *Stevens)

Taxes - As introduced, authorizes electronic submission of the report from the commissioner of revenue to the finance, ways and means committees of the senate and the house of representatives regarding tax credits claimed for the gross premiums tax and job tax. - Amends TCA Title 67.

HB 0779 by *Ramsey, Whitson (SB 1137 by *Swann, Yager)

Taxes, Sales - As introduced, increases, from \$100,000 to \$200,000, the maximum amount of annual sales that charitable entities whose primary purpose is fundraising in support of a city, county, or metropolitan library system may make to be excluded from the definition of "business" for sales tax purposes; authorizes such entities to make sales during temporary sales periods that occur no more than four times per calendar year. - Amends TCA Section 67-6-102.

HB 1193 by *Wright, Lafferty, Daniel, Ragan, Bricken, Calfee (SB 1126 by *Briggs)

Taxes, Sales - As introduced, reduces from 1.125 percent to 0.5 percent the percentage the department of revenue keeps from the proceeds from the local option sales tax to defray the state's expenses in administering, collecting, and remitting local sales taxes. - Amends TCA Title 67, Chapter 6.

HB 0690 by *Johnson C, Hodges, Reedy (SB 0648 by *Kurita, Gardenhire)

Taxes, Sales - As introduced, allocates a portion of sales and use tax revenue to certain counties in which a new event center is to be constructed. - Amends TCA Title 67, Chapter 6.

HB 1268 by *Haston (SB 0721 by *Gardenhire)

Revenue, Dept. of - As introduced, increases from 10 to 12 days the deadline for requesting a formal hearing before the commissioner on adverse action proposed or taken to implement any revenue regulatory or registration law administered by the commissioner, not including those laws relating to assessments or levies of taxes, fees, fines, penalties, interest, or the waiver of penalties. - Amends TCA Title 67.

HB 0124 by *Hodges, Baum (SB 0198 by *Johnson)

Taxes - As introduced, enacts the "Tennessee Local Education Capital Investment Act." - Amends TCA Title 67, Chapter 6.

[HB 0787](#) by *Hall, White, Russell, Ramsey, Wright, Moon, Crawford, Griffey, Doggett (SB 0673 by *Briggs, Kyle, White)

Veterans Services, Dept. of - As introduced, requires the department to provide training in mental health crisis management to the employees of the department who directly interact with veterans for the purposes of assisting veterans with mental health issues. - Amends TCA Title 58, Chapter 3.

Public Health - As introduced, creates the state Alzheimer's disease and related dementia advisory council. - Amends TCA Title 4; Title 68, Chapter 11, Part 14 and Title 71.

[HB 0176](#) by *Hall, Gant, Curcio, Griffey, Doggett (SB 0309 by *Lundberg, Bailey)

Insurance Companies, Agents, Brokers, Policies - As introduced, expands types of crop insurance offered under a limited lines producer license to include damage to crops caused by unfavorable weather conditions, fire or lightning, flood, insect infestation, disease, or other yield-reducing conditions or perils, in addition to present coverage for hail. - Amends TCA Title 43 and Title 56, Chapter 6.

[HB 0002](#) by *Staples, Ogles, Lamberth, Jernigan (SB 0010 by *Briggs, Haile, Pody, Kyle)

Sentencing - As introduced, enacts the "JaJuan Latham Act," which increases the penalty for an aggravated assault or homicide that occurs by a person discharging a firearm from within a motor vehicle and the victim is a minor at the time of the offense. - Amends TCA Title 39, Chapter 13, Part 1 and Title 39, Chapter 13, Part 2.

[HB 0156](#) by *Whitson, Curcio, Jernigan (SB 0264 by *Niceley, Crowe)

Criminal Offenses - As introduced, creates the Class E felony of tampering with, destroying, or interfering with any pipeline, pumping station, or equipment used to transport, store, or distribute crude or refined petroleum products or natural gas. - Amends TCA Section 39-14-411.

HB 0825 by *Sherrell, Curcio (SB 0681 by *Gardenhire)

Criminal Offenses - As introduced, increases the penalty for theft of property that includes a firearm valued at less than \$2,500 from a Class A misdemeanor or Class E felony, as applicable based on the value, to a Class D felony. - Amends TCA Title 37; Title 39 and Title 40, Chapter 35.

HB 0502 by *Eldridge (SB 0911 by *Southerland)

Criminal Offenses - As introduced, enhances the penalty for destruction or alteration of governmental records from a Class A misdemeanor to a Class E felony. - Amends TCA Title 39.

HB 0909 by *Keisling, Doggett, Jernigan, Calfee, Griffey, Whitson, Sherrell, Towns, Parkinson, Faison, Lamberth, Curcio, Garrett, Eldridge, Beck, Camper, Howell, Carter, Johnson C, Mitchell, Potts, Sanderson, Littleton, Hulse, Van Huss, Hazlewood, Thompson (SB 1039 by *Gardenhire, Crowe, Kyle, Bowling)

Elder Abuse - As introduced, enacts the "Elderly and Vulnerable Adult Protection Act of 2019." - Amends TCA Title 39; Title 40 and Title 71.

HB 0917 by *Keisling, Littleton, Curcio, Sherrell, Eldridge, Garrett, Griffey (SB 1359 by *Yager, Bowling)

Child Abuse - As introduced, creates the Class A misdemeanor and Class E felony offenses of withdrawing, transferring, or altering a child's school enrollment with intent to hinder an active child abuse or child neglect investigation. - Amends TCA Title 37; Title 39 and Title 49.

HB 0972 by *Littleton, Curcio (SB 0597 by *Lundberg)

Criminal Offenses - As introduced, creates the Class C felony offense of communicating a threat of public harm; authorizes juvenile detention for juveniles communicating a threat of public harm. - Amends TCA Title 37; Title 39, Chapter 13; Title 39, Chapter 17 and Title 40, Chapter 35.

HB 0565 by *Dunn, Sparks, Coley, Ogles, Doggett, Curcio, Camper, Parkinson, Lamberth, Towns, Griffey (SB 1252 by *Gresham, White, Massey)

Statutes of Limitations and Repose - As introduced, extends civil and criminal statutes of limitation for certain acts of abuse against minors; increases the penalty for intentional failure to report child abuse or child sexual abuse. - Amends TCA Title 28; Title 37 and Title 40.

HB 1264 by *Holt, Casada, Lamberth, Curcio, Van Huss, Sexton C, Doggett, Littleton, Carter, Haston, Gant, Weaver, Moon (SB 0705 by *Stevens, Bell)

Handgun Permits - As introduced, creates a concealed handgun carry permit, which allows a person to carry a concealed handgun; redesignates the existing handgun carry permit as an enhanced handgun carry permit. - Amends TCA Title 10; Title 33; Title 38 and Title 39.

HB 1460 by *Sherrell (SB 1347 by *Pody, Gresham, Haile, Jackson)

Handgun Permits - As introduced, waives the fee for obtaining a lifetime handgun carry permit for former law enforcement officers who served at least 10 years and left the law enforcement agency while in good standing. - Amends TCA Section 39-17-1351.

HB 0921 by *Cepicky, Hill M, Littleton (SB 0616 by *Hensley)

Children's Services, Dept. of - As introduced, requires a maximum caseload of 20 for case managers; creates a maximum caseload of 10 for foster care case managers; requires the department to comply with the maximum caseload ratios. - Amends TCA Title 37, Chapter 5.

HB 0867 by *DeBerry, Littleton (SB 1403 by *Bell)

Child Abuse - As introduced, requires the commissioner of children's services to provide a report to the district attorney general with jurisdiction following a fatality or near fatality of certain children; requires an immediate investigation into a report of child abuse from a party tasked with the education or health and welfare of the child. - Amends TCA Title 37.

HB 0729 by *Lamberth, Camper, Parkinson, Doggett (SB 0667 by *Haile)

Courts - As introduced, sets the minimum compensation payable to officially designated and auxiliary court reporters designated as licensed court reporters by the Tennessee board of court reporting at the rates of \$350 per full-day appearance and \$175 per half-day appearance. - Amends TCA Title 8, Chapter 23; Title 20, Chapter 9, Part 6; Title 20, Chapter 9, Part 1 and Title 40, Chapter 14, Part 3.

HB 0608 by *Curcio, Littleton, Reedy, Griffey (SB 0512 by *Roberts, Kurita)

Courts - As introduced, adds an additional trial court in the 23rd judicial district comprised of Cheatham, Dickson, Houston, Humphreys, and Stewart counties effective September 1, 2019, with the additional judge or chancellor to be appointed by the governor; authorizes the voters of the 23rd judicial district to elect the additional judge or chancellor at the August 2020 general election to serve until September 1, 2022. - Amends TCA Title 8; Title 16; Title 17 and Title 18.

HB 0569 by *Holsclaw, Hazlewood (SB 0861 by *Crowe)

Public Defenders - As introduced, allows district investigators to include experience as a criminal defense investigator for prior service credits. - Amends TCA Title 8, Chapter 14, Part 1.

[HB 1400](#) by *Hicks, Littleton, Curcio, Farmer, Griffey, Hulsey, Doggett, Sherrell, Carter, Faison, Carr, Calfee, Staples, Eldridge, Powers (SB 1473 by *Bailey)

District Attorneys - As introduced, creates 11 additional assistant district attorney general positions, 10 additional secretarial positions, four additional victim-witness coordinator positions, and five additional criminal investigator positions to be designated in judicial districts as provided in a report prepared by the district attorneys general conference. - Amends TCA Title 16, Chapter 2.

[HB 0384](#) by *Weaver, Hill T (SB 0029 by *Haile, Bowling, Bailey, Reeves)

Insurance, Health, Accident - As introduced, extends compensation for death of emergency responders to emergency medical technicians and paramedics; authorizes local governments to continue to provide health insurance to the surviving spouse and children of an emergency medical technician or paramedic killed in the line of duty. - Amends TCA Title 7, Chapter 51, Part 2 and Title 8, Chapter 27.

[HB 0316](#) by *Hicks, Carr, Russell, Gant, Casada, Helton, Reedy (SB 1442 by *Bailey, White)

Firefighters - As introduced, creates a presumption that certain conditions or impairments of full-time firefighters caused by certain cancers occurred in the course of employment unless the contrary is shown by competent medical evidence. - Amends TCA Title 7, Chapter 51, Part 2.
