Homestead Exemptions - As introduced, increases the homestead exemption relative to garnishments; creates homestead exemption for agricultural land; requires the fiscal review committee to recommend to the general assembly every three years suggested increases in the homestead exemption. - Amends TCA Title 26 and Title 30.

[HB 0626](#) by \*Lamberth, Garrett, White (SB 0590 by \*Haile)

Public Records - As introduced, authorizes a records custodian to petition a court for an injunction to prohibit a person from making records requests that constitute harassment. - Amends TCA Title 10, Chapter 7, Part 5 and Title 29.

[HB 1131](#) by \*Curcio (SB 0409 by \*Stevens)

Bail, Bail Bonds - As introduced, creates a rebuttable presumption that a person charged with a bailable offense will not violate the conditions of their release if the offense is expungeable and the person has not been previously convicted of an offense that is ineligible for expunction. - Amends TCA Title 40, Chapter 11 and Title 40, Chapter 7.

Criminal Procedure - As introduced, restores the voting rights of persons convicted of certain infamous crimes upon receipt of a pardon or completion of any sentence of incarceration, parole, or probation. - Amends TCA Section 2-2-102 and Title 40, Chapter 29.

**HB 1453 by \*Curcio (SB 1410 by \*Bell)**

Indigents - As introduced, states that the court in a criminal proceeding or juvenile delinquency proceeding may request the person claiming to be indigent provide relevant documents to assist the court in making a determination of indigence. - Amends TCA Title 8, Chapter 14; Title 8, Chapter 21; Title 16; Title 20, Chapter 12; Title 33; Title 36; Title 37; Title 39; Title 40 and Title 55.

**HB 1257 by \*Curcio, Carter, Littleton, Van Huss, Farmer, Sexton C, Gant, Lamberth, Garrett, Tillis, Sherrell, Griffey (SB 1408 by \*Bell)**

Courts - As introduced, requires that appointments to the offices of senior judge, chancellor, circuit court judge, criminal court judge, or judge of any other trial court of record, district attorney general, and district public defender be confirmed by general assembly before appointees take office. - Amends TCA Title 2; Title 4; Title 8; Title 16; Title 17 and Title 38, Chapter 6.

State Symbols - As introduced, designates "The Volunteer State" as the official nickname of this state. - Amends TCA Title 4, Chapter 1, Part 3.

**[HB 1544](#) by \*Staples, Hakeem, Hardaway, Chism, Parkinson, Lamar**

Holidays and Days of Special Observance - As introduced, designates Emancipation Day, August 8 each year, as a state legal holiday. - Amends TCA Title 15.

**[HJR 0686](#) by \*Staples**

General Assembly, Statement of Intent or Position - Suggests removing Nathan Bedford Forrest bust from State Capitol and replacing it with tribute to more deserving Tennessean. -
