AN ACT to amend Tennessee Code Annotated, Section 49-7-113, relative to age of senior citizens to audit courses at state-supported colleges or university without paying tuition charges or fees.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF TENNESSEE:

SECTION 1. Tennessee Code Annotated, Section 49-7-113(a)(1), is amended by deleting the language "sixty (60) years", and by substituting instead the language "fifty-five (55) years".

SECTION 2. Tennessee Code Annotated, Section 49-7-113(b), is amended by deleting the language "sixty-five (65) years", and by substituting instead the language "fifty-five (55) years".

SECTION 3. This act shall take effect upon becoming a law, the public welfare requiring it.
