

AN ACT to amend Tennessee Code Annotated, Title 4, Chapter 29, relative to the review of agencies, commissions and departments by the government operations committees.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF TENNESSEE:

SECTION 1. Tennessee Code Annotated, Section 4-29-118(a), is amended by deleting the first sentence in its entirety and by substituting instead the following:

Notwithstanding any provision of law to the contrary, each department, commission, board, agency or council of state government initially created after January 1, 1995, shall terminate on June 30 of the second calendar year following the year in which such governmental entity is created.

SECTION 2. Tennessee Code Annotated, Section 4-29-217(b), is amended by deleting the language "June 30, 1996" and by substituting instead the language "June 30, 1997".

SECTION 3. Tennessee Code Annotated, Section 4-29-218(b), is amended by deleting the language "June 30, 1997" and by substituting instead the language "June 30, 1998".

SECTION 4. Tennessee Code Annotated, Section 4-29-219(b), is amended by deleting the language "June 30, 1998" and by substituting instead the language "June 30, 1999".

SECTION 5. Tennessee Code Annotated, Section 4-29-220(b), is amended by deleting the language "June 30, 1999" and by substituting instead the language "June 30, 2000".

SECTION 6. Tennessee Code Annotated, Section 4-29-221(b), is amended by deleting the language "June 30, 2000" and by substituting instead the language "June 30, 2001".

SECTION 7. Tennessee Code Annotated, Section 4-29-222(b), is amended by deleting the language "June 30, 2001" and by substituting instead the language "June 30, 2002".

SECTION 8. Tennessee Code Annotated, Section 4-29-223(b), is amended by deleting the language "June 30, 2002" and by substituting instead the language "June 30, 2003".

SECTION 9. This act shall take effect upon becoming a law, the public welfare requiring it.
