

SENATE BILL 2663

AN ACT to amend Tennessee Code Annotated, Section 57-5-108, relative to penalties upon beer license holders for violations of the laws regarding possession, sale or transportation of beer and alcoholic beverages with an alcoholic content not greater than five percent by weight.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF TENNESSEE:

SECTION 1. Tennessee Code Annotated, Section 57-5-108(a)(2), is amended by deleting the subdivision in its entirety and by then substituting the following:

A city, class A county, or class B county, or any committee, board or commission created by such governmental bodies, may, at the time it imposes a revocation or suspension, impose one of the following additional civil penalties:

- (i) a civil penalty not to exceed One Thousand Five Hundred Dollars (\$1,500) for each offense of making or permitting to be made any sales to minors; or
- (ii) a civil penalty not to exceed One Thousand Dollars (\$1,000) for any other offense.

SECTION 2. Tennessee Code Annotated, Section 57-5-108(b), is amended by deleting the second sentence and by substituting instead the following:

The license of permit may be suspended for a period not to exceed ten (10) days and a civil penalty up to One Thousand Five Hundred Dollars (\$1,500) may be imposed pursuant to subdivision (a)(2) of this section.

SECTION 3. This act shall take effect upon becoming a law, the public welfare requiring it.
